

**RHINOS RUGBY ACADEMY
RELEASE AND WAIVER OF LIABILITY AND
AUTHORIZATION REGARDING PHOTOS AND VIDEOS**

I acknowledge that by signing this document, I am agreeing to release the Released Parties from liability. I have therefore been advised to read this document carefully before signing it.

This Release and Waiver of Liability, and Authorization Regarding Medical Information and Photos and Videos (“Release”) is entered into by the undersigned “Player” and the Player’s Parent/Guardian, if applicable, in favor of Rhinos Rugby Academy, its successors, assigns, owners, directors, officers, employees, volunteers, coaches, members, affiliates, partners, sponsors, vendors, contractors, contracted entities and facilities and the owners and lessors thereof (collectively referred to as “Rhinos Academy” or the “Released Parties”).

I understand that being a part of and training at Rhinos Academy is voluntary – it is a privilege not a right. In consideration for the privilege of being a part of and training at Rhinos Academy, I and my Parent/Guardian, if applicable, acknowledge and agree as follows:

1. Being a part of and training at Rhinos Academy includes various rugby-related activities, including but not limited to, warm-up, training, practice, games, clinics, travel, and social events (referred to herein as the “Activities”). Such Activities include participation in a full-contact sport, require good health and fitness and can be hazardous and present a danger to me. I believe I am qualified to participate in the Activities, and if at any time I believe the conditions to be unsafe, I will immediately discontinue further participation in the Activities.

2. Participation in Activities exposes me to risks of serious bodily injury, including permanent disability, paralysis and death. Risks may arise out of contact and/or participation with other players, spectators, equipment, field, facility and/or fixed objects; falls, collisions, rough play, and other mishaps; exposure to adverse weather conditions; flaws and defects in equipment and facilities; irregular field conditions; and negligent field maintenance, negligent officiating, negligent coaching and negligent participation. Risks may be caused by my own actions, or inaction, the actions or inaction of others players, the condition of the facilities in which the Activities take place, and/or the negligence of the “Released Parties.” There may be other risks and social and economic losses either not known to me or not readily foreseeable at this time.

3. Assumption of the Risks. I and my Parent/Guardian, if applicable, consent to participation in the Activities and fully accept and assume all such risks and all responsibility for losses, costs, and damages incurred as a result of such participation.

4. Waiver and Release of Liability. In consideration for the privilege of my participation in

the Activities, I and my Parent/Guardian, if applicable, hereby release, indemnify, and hold harmless Released Parties from and against any claim, damages, suit, liability or responsibility asserted against Released Parties in connection with any injury, misadventure, harm, loss, accident, illness, death, inconvenience, or damage sustained by me as a result of participation in the Activities, whether or not caused by the fault or negligence of any of Released Parties.

Authorization Regarding Photos and Videos: I hereby give my permission to Rhinos Academy to (1) photograph and/or videotape me during Activities, (2) use any photographs, videos, images, likeness, utterances or statements in which I may be involved, in whole or in part, in any media, including the Internet, for promotional, fundraising or other purposes, without approval or compensation, and (3) reproduce and grant authorization to reproduce any photographs, videos, images, likeness, utterances or statements in all domestic and foreign markets. I hereby release Rhinos Academy from any and all liabilities and/or claims in connection with the use of any such photographs, videos, images, likeness, utterances or statements.

6. Governing Law: I understand and agree that this document is intended to be as broad and inclusive as permitted under applicable law and shall be governed by California law.

Severability: If any provision of this document is determined to be invalid for any reason, such invalidity shall not affect the validity of any of the other provisions, which other provisions shall remain in full force and effect as if this document had been executed with the invalid provision eliminated.
